In consideration of the undersigned's request that his or her child be permitted to participate in Work to Ride, Inc/Chamounix Equestrian Center instructional equestrian program, the undersigned acknowledges and agrees that:

The undersigned agrees to ensure that his / her minor child adheres to safety guidelines, practices and procedures concerning all aspects related to participation in the equestrian program, including but not limited to proper dress and safety equipment.

The undersigned knowingly and voluntarily assumes any and all risks, known or unknown, associated with the minor child's participation in Work to Ride/Chamounix Equestrian Center, even if such injury or harm results from the negligence of the undersigned, the minor child or any other third party.
